2.1 Purpose:

The purpose of the skills programme is to build the capacity of a person to act as an Intermediate Emergency First Aid Responder.

Intermediate Emergency First Aid Responders:

- Treat and support life on severe injuries and medical conditions in the event of an emergency.

- Stabilise the person's condition and prevent further harm until more advanced medical treatment can be provided.
- Manage the incident scene, coordinating with other responders and emergency services, and providing support to the casualties and their families.

(b) Responsibilities:

- Incident scene assessment is conducted, and actions initiated to ensure the safety of self, affected persons and bystanders.
- Professional primary assessments of the affected persons are done, and life-threatening conditions are identified.
- Intermediate emergency first aid techniques are applied to immediately stabilise injured and ill casualties by opening airways, facilitating breathing, stopping bleeding, and managing shock.
- Intermediate emergency first aid care is provided to manage cardiac arrest or heart attack and apply emergency first aid to preserve life and prevent further harm until a next level of medical help arrives.
- Intermediate emergency first aid care is provided to manage stroke and apply emergency first aid to preserve life and prevent further harm until a next level of medical help arrives.
- Intermediate emergency first aid care is provided to manage Anaphylaxis and apply emergency first aid to preserve life and prevent further harm until a next level of medical help arrives.
- Intermediate emergency first aid care is provided to Diabetic emergency and apply emergency first aid to preserve life and prevent further harm until a next level of medical help arrives.
- Intermediate emergency first aid care is provided to deal with seizures and apply emergency first aid to preserve life and prevent further harm until a next level of medical help arrives.
- Intermediate emergency first aid care is provided to deal with water emergencies and preserve life in cases of near drowning.

(c) Contexts:

- Basic organisational processes for doing hazard identification during an emergency at different incident scenes at work, in the community and at home.
- Basic organisational processes for ensuring the safety of persons during different kinds of emergencies.
- Organisational processes for applying lifesaving first aid care.

2.3.2. Task 2

Conduct professional secondary assessments of the affected persons, in an emergency situation, to identify injury and health conditions that requires further first aid care.

(a) Unique Product or Service:

- Secondary patient assessments completed.
- Intermediate care provided.

- Patients handed over.
- Post treatment actions completed.

(b) Responsibilities:

- Visual and physical assessments of injured and ill persons are conducted in an ethical and systematic manner following prescribed protocols and procedures.
- Injuries and signs of common illnesses are identified, recorded and decisions are made regarding the appropriate immediate treatment of the identified conditions.
- Suspected life-threatening conditions are immediately reported to the next level of medical care and instructions for further action recorded and executed.
- Ongoing appropriate communication with the affected person is maintained and additional information recorded.

(c) Contexts within which the task is executed:

Organisational Processes for care of injured and ill people.

2.3.3. Task 3

Provide intermediate emergency first aid care to manage identified injuries and health conditions and prevent loss of life.

(a) Unique Product or Service:

Use a variety of common instruments and processes to apply intermediate level first aid to provide care, relieve pain and facilitate healing in relation to the identified patient conditions in an emergency situation.

(b) Responsibilities:

- Intermediate emergency first aid care is taken to maintain and protect persons suffering from head and spinal injuries.
- Intermediate emergency first aid care is provided to manage chest injuries.
- Intermediate emergency first aid care is provided to manage abdominal injuries.
- Intermediate emergency first aid care is provided to manage pelvic injuries.
- Intermediate emergency first aid care is provided to manage extremity trauma by treating and immobilising fractures.
- Intermediate emergency first aid care is provided to manage burns and preserve life and prevent further harm until a next level of medical help arrives.
- Intermediate emergency first aid care is provided to Thermal stress: Range: Hyper and hypo thermia

- Intermediate emergency first aid care is provided to deal with inhaled, injected, ingested, and absorbed poisoning.
- Intermediate emergency first aid care is provided to treat animal and insect bites and stings.
- Intermediate emergency first aid care is provided to limit the risks of exposure when encountering a communicable disease and the condition is immediately reported.
- Execute proper and legal handover of affected persons after providing first aid treatment and ensure appropriate post incident cleanup where required.

3.1 Knowledge Module (KM) – 01: 900233-000-00-KM-01 Concepts and Principles of Intermediate Emergency First Aid, NQF Level 3, Credits 2.

3.1.1 Module Details:

(a) Purpose of Knowledge Module:

The purpose of this knowledge module is to equip learners with a basic operational understanding of the key concepts and principles that underpin the tasks performed by a basic emergency first aider.

This module aims to provide learners with the necessary foundational knowledge and understanding to effectively respond to emergency situations and deliver immediate life-saving care.

By exploring the principles of first aid, learners will gain insights into assessing and managing common injuries and medical emergencies, prioritising patient safety, applying appropriate techniques for resuscitation and wound care, and effectively communicating with emergency medical services.

The learning will be delivered in a blended training mode. Blended training refers to a learning approach that combines both online or digital learning methods with traditional in-person or face-to-face instruction. It is a hybrid learning model that leverages the advantages of both online and offline learning environments to create a comprehensive and flexible training experience. It should be able to deliver this module in ten notional hours depending on the readiness and commitment of learners and facilitators.

Notional hours refer to the estimated amount of time required for a learner to complete a specific course or training program. It represents the total learning hours, including both the contact hours (actual time spent in instruction or interaction with instructors) and the non-contact hours (time spent on independent study, assignments, assessments, and other learning activities). Notional hours provide a standardised measure for planning and assessing the workload and intensity of a course or program. They serve as a guideline for estimating the time commitment needed by learners to achieve the desired learning outcomes.
